This agreement is between Lazy Days Campground Inc., and the following persons:

Do not include grandchildren, or adult children.

Only the persons named here are the “Campers” of this campsite. The Campers’ address and other information are on the last page of this agreement. Any adults not listed on this agreement must pay visitor fees, and will not receive a seasonal car sticker.

Defined Terms. Some of the terms used in this Agreement have definitions. Those terms are Capitalized and listed in the Definitions portion of this Agreement. The definitions stated in that section apply in this Agreement.

Camping Agreement. When this Agreement is signed by the Campground and the Camper(s); and the required Deposit has been Paid, the Camper is granted the right of admission to the Campground and the right to place an agreed upon Unit on the identified Campsite, and to Occupy the Campsite until the end of the Period stated in this Agreement, subject to all Conditions in this Agreement.

Assigned Campsite. The Camper is assigned the Campsite known as: _____ . Lazy Days Campground will place trailer on site. Trailers will not be placed/moved on weekends. Camper MUST inspect site prior to signing agreement. No refunds will be given.

Period of Use. The Camper may use the Campsite starting on April 1, 2026. The Camper may not occupy the Campsite more than seven months (ATCP 79.11), or after October 31st, 2026, or after an earlier date of Early Termination. **Campsite is NOT accessible during the off season, Nov. 1st through Mar. 31st.**

NOT A LEASE. This Agreement is a contract which is binding on both the Campground and the Camper. This Agreement is not a lease of real estate. The Camper is not a tenant. This Agreement is, for legal purposes, a license to use the property of the Campground on the conditions which are stated in this Agreement.

NOT A RESIDENCE. Under Wisconsin law, campgrounds are not allowed to be a permanent residence. **Camper may not claim the Campground as their permanent address, voting address, DMV address, Job application address, or other place of residence.**

Size limit: Travel Trailer and tow vehicle are not to exceed 69 feet long, 8 feet wide, and must be self-contained. If you need a permit to pull it, you can't have it here. For questions, call (262) 675-6511.

Electricity: The amenity fee for electricity to the Campsite. Do not charge electric cars on our power.

Late Payment Fee. Any fees or charges which are not paid when due are subject to a late payment fee of \$35. Non-payment is grounds for Early Termination of this agreement. There is no grace period on due dates.

Agreement: This Seasonal Campground Agreement between the undersigned person and the Campground.

Camper: The person who signs this Agreement and the other persons who are named in the Agreement.

Camper Unit: The recreational vehicle placed on the Campsite.

Campground: Lazy Days Campground Inc.

Campsite: The area of land identified by the Campground which the Camper occupies during the Period.

Early Termination: The revocation by the Campground of a Camper's permission to occupy a Campsite.

Guest: A person who is authorized by the Campground and Camper to occupy the campsite for the time permitted in the rules section of this Agreement.

Notice: To inform a Camper or Guest of a fact or condition related to this Agreement. Notice is given under this Agreement by informing any of the adult Campers of a fact or condition, except that Notice of Early Termination or Late Payment Fees shall be given in writing. If no adult Camper is present at the Unit, it is sufficient under this Agreement to place the Notice on the Unit or by e-mail. Notice to the Campground must be given in writing to the Campground manager.

Pay: To satisfy the entire amount owed to the Campground, all obligations being due immediately; if a check or credit card is used, the obligation is not satisfied until the final credit has been given to the Campground.

Occupy: The physical presence of a Unit, a Camper or a Guest on the Campground or Campsite, whether or not staying overnight.

Minor: Any person under the age of 18 years old.

Rules: Standards of conduct and expectations that are established by the Campground to maintain the harmonious and orderly ambiance of the Campground and maximize the enjoyment of the Campers and Guests, as well as the General Obligation to behave in an orderly, polite manner which is respectful of other Campers.

Unit: A recreational vehicle which is placed on a Campsite for use by a Camper and Guests. Guests are not allowed to use a Camper's unit without paying visitors overnight fee, and without notifying the campground that Campers will not be present.

Campground's Obligations. The Campground's goal is to see that all Campers and their Guests enjoy the recreational opportunities offered by the Campground. To do so, the Campground will provide its Campers and Guests with certain services and amenities, and use its best efforts to assure that all Campers and Guests cooperate in maintenance of the Campground's desired ambiance.

Campsite. The Campground will allow the Camper the use of a Campsite for all lawful purposes consistent with the Campground's Rules.

Campground Common Features and Attractions. The Campground will allow the Camper to use its common features and attractions, which are shared with all other Campers. Because of varying numbers of Campers, maintenance requirements and weather, there is no guaranty of availability of any common features or attractions.

Camper's Obligations. General Obligation. The Camper will use the Campsite in a manner which is safe, orderly, lawful, sanitary, clean and respectful of the rights of other Campers and of the Campground's property and other Guests.

In addition to this General Obligation, Campers must do all of the following:

- A) The Camper will Pay all deposits, fees and charges when due.
- B) The Camper will assure that all obligations of this Agreement are understood by all of the Campers and Guests, including children. The adult Campers will monitor and supervise all minor Campers to assure that the minors abide by the requirements of this Agreement.
- C) The Camper shall maintain liability, fire, wind and other hazard insurance coverage on their personal property located on the Campsite. The insurance policy must provide coverage of the Camper's acts or omissions related to the Campground and Campsite. Camper must have liability insurance on all motor vehicles operated on the Campground, including golf carts and other vehicles which are not licensed for use on public roads. The Camper shall provide a copy of the policies' Declarations pages to the Campground.

- D) The Camper shall maintain the Camper Unit according to the manufacturer's recommendations. Camper understands that only RVIA-Approved Recreation Vehicles may be placed on the Campsite.
- E) The Camper and Guests shall abide by all directions of Campground staff, obey all signs and signals on the Campground. The Campground has 1 Stop Sign at the entrance, everyone must stop completely for this sign.
- F) The Camper and Guests shall not enter closed areas or other Campsites without permission.
- G) By signing this Agreement, the Camper acknowledges that the Camper has been given a copy of the Campground Rules. The Camper also agrees that the Camper has had the opportunity to inspect the Campsite and accepts it in its current condition. The information provided by the Camper is correct.
- H) The Camper agrees to abide by and follow all applicable state laws, rules and ordinances.

Limitations on Campground Liability. The Campground desires to provide Campers with an enjoyable camping experience. However, camping takes place in an outdoor recreational setting. There are aspects of any recreational experience that cannot entirely be controlled or made free of risk. The Campground is not liable for weather conditions, natural events, damages caused by wrongful conduct or carelessness of others. By signing this Agreement, the Camper acknowledges that by participating in recreational activities, the Camper accepts the risks to themselves, their Guests, their Units, their Vehicles, and their personal property, which are inherent in the recreational activity. The Camper is advised that Wisconsin law (Section 895.525, Wis. Stats.) limits the liability of the Campground and imposes duties on the Camper to take precautions for their own safety, and personal property, while engaged in recreational activities.

Reimbursement of Campground for Losses Caused by Camper. In the event that any action or omission of the Camper or Guests of the Camper cause the Campground to pay damages to any other person or party, the Camper shall reimburse the Campground for those damages, as well as the attorney's fees and expenses incurred by the Campground.

Termination of Agreement. This Agreement terminates on the expiration date. On or before that date, the Camper will remove the Unit from the Campground, quietly and peacefully. The Camper is responsible for removing the unit with appropriate care for the Campsite to restore the Campsite to its original condition. The Campground may determine, for any reason in the Campground's sole discretion, that it is necessary for the Camper to leave the premises of the Campground prior to the scheduled end of the Period. In such an event, the Campground will direct the Camper to leave the Unit and the Campground. The Camper will be given one (1) day to cease to occupy the Unit and Campground, and five (5) days to remove the Unit from the Campground. In the event of a disturbance of the peace or order of the Campground, the Campground reserves the right to require the Camper to leave immediately. If the Agreement is terminated early, whether it's the decision of the Camper or the Campground, the Camper has no right to a refund.

Winter Storage. The Campground may allow the Unit to remain on the premises of the Campground during the period between the end of the season for which this Agreement was executed and the commencement of an additional period. The fee for winter storage shall be \$80 only if an agreement has been made for the ensuing camping season. The Campground is not required to agree to allow a Unit to be stored on the Campground. Agreement to permit winter storage does not obligate the Campground to agree to permit the Camper to Occupy the Campsite in the ensuing camping season. The Camper must properly prepare the campsite and Unit for winter storage according to the Campground Rules. During winter storage, no one may Occupy a Unit or a Campsite. We strongly recommend securing you propane tanks and batteries.

Winterizing. Lazy Days Campground no longer offers winterizing. The Camper understands that they are solely responsible for making sure their Unit is winterized. The Camper understands that winterizing must be completed by October 31st, at pm, no exceptions. No Campers or RV Serviceman will be admitted to the Campground after pm on October 31st.

Removal of Units. If a Camper fails to remove a Unit as required by this Agreement, the Camper acknowledges that the Campground has the right to remove the Unit. The Campground will attempt, before removing the Unit, to notify the Camper and provide the Camper with five (5) days to remove the Unit. After 5 days the Campground will remove the Unit. The Camper acknowledges that the Campground is not responsible for damage to the Unit caused by its removal from the Campsite. The Camper shall pay the Campground's expenses to remove the Unit, a flat fee of \$150, and the campground will turn the unit over to local law enforcement, and the unit may be impounded at the Camper's expense.

Charge For Non-Removal. There shall be a charge of \$25 per day for non-removal of a Unit on or before the date on which the Unit should be removed, which shall commence on the date of termination and continue until the Unit is removed from the Campsite/Campground.

No Transfers or Assignments of Agreement. This Agreement is solely between the Camper and the Campground. The Camper may not transfer this Agreement to any other person or persons, or assign the Camper's obligations to any other person. The sale or repossession of a Unit shall result in Early Termination, and removal of the Unit unless the Campground agrees, in its sole discretion, to enter into a new agreement with the new Camper.

General Terms and Conditions. The Campground may not be deemed to have waived any requirement of this Agreement by failing to enforce terms of the Agreement. The Rules adopted by the Campground are part of the agreement between the Campground and the Camper. No oral modifications of this Agreement control. This Agreement is controlled by Wisconsin law.

Campground Rules

- 1) **Ask Management** If you are unsure about a rule or what to do. Do not ask your neighbor.
- 2) **Traffic** – The speed limit at Lazy Days Campground is **5 MPH**, and is strictly enforced. **We have 1 stop sign at the entrance. All vehicles MUST stop completely for this sign!** Do not detour across other people's sites. Stay on the roads. All state traffic statutes relating to the safe operation of motor vehicles will be strictly enforced; including: Driving while intoxicated, reckless driving, and speeding. Passengers are not permitted to ride, sit, or stand on rails or tailgates of trucks, or ride outside of any motor vehicle. **Violators will be removed from the campground with no refund. Suspected DWI's and DUI's will be reported to the Washington Co. Sheriff for prosecution.**
- 3) **Tents** – Screen tents and light weight camping gazebos are allowed. Max size is 12'x12', cloth/canvas tops only.
 - a) **RV Site** – Tents are not allowed on sites the have an RV Unit, unless given written permission from management (for minors only).
 - b) **Tent site** – One large tent (sleeps 4 to 6), **or** two small tents (sleeps 3 or less) Group size is limited to a max of 6 adults, **or** one single family per site.
 - c) **Seasonal** – Tents are not allowed on sites the have an RV Unit, unless given written permission from management (for minors only).
- 4) **Firearms** – No discharging of any type of weapons and no open carry in the campground.
- 5) **Fireworks** – No fireworks allowed. Sparklers are allowed. **Violators will be turned over to the Washington co. Sheriff.**
- 6) **No chainsaws** are allowed in the campground.
- 7) **All sites** must be kept neat and free of debris.
- 8) **Vehicles** – Two vehicles per site. No storing of vehicles or trailers is allowed on your site. Type of vehicles allowed on site is subject to management's discretion. Keep your vehicles on your site, even if adjacent sites are empty. Any damage done to other sites, caused by you or your guests, will be charged to you. No moped's, ATV's, Go-carts, Etc. **Do not charge electric vehicles on our power.**
- 9) **Golf Carts** – Please see Golf Cart Requirements form for golf cart rules.
- 10) **Boats** - You may not store your boat on your site without permission, even if you're a seasonal Camper. After use, it must be placed in storage. Any violation of this rule will result in you being asked to remove your boat from Lazy Days Campground. Boats on shore without permission will be removed. Boats must have site number stickers. No Pontoon/Deck Boats allowed in campground.
- 11) **Tarps**- No blue/bright colored tarps. Black, brown, and green tarps are permitted to cover things that would otherwise go in a shed (Ex. lawn mower). Please limit the number of tarps used during the season to two tarps, as they can be an eyesore.
- 12) **Guest Policy** – All guests, except for signatories and their minor children, must pay the visitor fee. \$3.50 per car, per day. \$6.00 per person, per night for overnight visitors. Maximum number of people per site is one camping family (Mom, Dad, and minor children) or a maximum of 6 adults. Visiting hours are 8am – 10pm (Sun – Thurs), and 8am – 11pm (Fri & Sat). No new visitors will be admitted to the campground after store close. Campers are responsible for the conduct of their guests.
- 13) **Children/Minors** – Minor children will not be allowed to stay at Lazy Days Campground without adult supervision. **Do not leave children unattended in the campground. Minors MUST be accompanied by an adult AT ALL TIMES.**
- 14) **Beach** – Hours are 8am – dusk. No bikes or pets on the beach. No glass bottles on the beach or in the water. No swimming after dark. NO LITTERING on or around the beach area. NO LIFEGUARD ON DUTY. It is the responsibility of the camper to supervise their children and guests. Releasing Lazy Days Campground, Inc. from all liability for any accidents that may occur.
- 15) **Pets** – **All pets must be kept on a leash at all times.** Do not leave dogs unattended or barking. They must be secured inside your unit when you leave the site. No pets on the beach. Check with office staff for where your pets can swim. You MUST pick up after your pets. 3 pets max. Pets must be contained in unit when not on leash/runner. No outdoor crating or kenneling allowed. Cruelty of any kind will not be tolerated.

16) **Campfires** – All campfires need to be contained and fully extinguished before retiring for the evening or leaving the campground. Do not leave fires unattended for an extended period of time. DO NOT burn trash, bottles, or cans in the fire pits. Take all trash to the dumpsters. "Locations are on the site map" **DO NOT DUMP CAMPFIRE ASH IN DUMPSTERS**

17) **Cigarettes** – Please carry an ashtray or a soda can. Do not leave cigarette butts on the ground.

18) **Noise/Quiet Time** – No loud radios, TV's, voices, or sounds that carry past your site are allowed at any time. Strict quiet time is Sunday – Thursday 10pm – 8am, Friday and Saturday 11pm – 8am. Our objective is to provide a peaceful and secure atmosphere for all of our campers. Underage drinking will not be tolerated. Disruptive or disorderly behavior will result in possible arrest or removal from the campground with no refund. **This includes loud arguments.** All minors must return to their sites during quiet time.

19) **Drugs** – Marijuana, and other illegal drug use is strictly prohibited. CBD vape juice/oil is not allowed to be used in the campground. **"Legal" variants of CBD/THC (Ex. Delta 8) are also not allowed here.** Violators will be removed immediately, and without warning. Medical Marijuana is not legal in the state of Wisconsin. You may be refused service and asked to leave if you smell like marijuana.

20) **Police** - If police presence is required for you, or your guests, for anything other than a medical emergency, you will be removed from the campground. **(Some examples. Domestic abuse, theft, trespassing, child welfare, loud fights, underage drinking, etc.)**

21) **Violation** of any of these rules, or being aggressive with staff, will result in removal from the campground without a refund.

Additional Rules for Seasonal sites - Must submit plans for any changes that you would like to make to the site.

22) **Gathering/Parties** – If you are planning to have a party or gathering that will have more than 2 visiting cars, let the office know so parking arrangements can be made.

23) **Sites**, and trailers are expected to be kept in a clean and presentable condition. **This includes the exterior of you trailer.** Trailer exteriors must be cleaned at the end of each season, and maintained throughout the season. All personal property must be at least 2.5 feet away from the site line. Units must be 5 feet away from the site line, with slides out.

24) **Gazebos** - light weight camping gazebos are allowed. Max size 12'x12', cloth/canvas tops only. Decking may be placed underneath but may not be connected to trailer deck. Decking may not exceed inches past the gazebo, and may not be higher than inches off the ground. **Decking still needs to be built in sections not exceeding 6.5'x6.5' or 4'x8' sections.**

25) **Decks**- sections must be placed next to each other, be no larger than 4'x8', no more than one foot off the ground, not exceed trailer length, and must be removable. No permanent structures.

26) **No railings** are allowed on the platforms (see management for the exception to this rule)

27) **No fencing** is allowed on your site.

28) **Lights** across awnings only. You may not have lights all over the site and lights must be turned off after retiring for the night or when you are gone for an extended period of time. (ask management for exceptions)

29) **Cutting the grass** of the seasonal sites is not included with the seasonal site fee. **Your grass on the entire site must be mowed, including behind your Unit, and the site must be trimmed at least once every 2 weeks, starting May 15th of each season, and maintained throughout the season. If the grass grows above 5 inches, a \$50 fee will be applied to your site. If this happens more than 2 times in a season, the agreement will be terminated. We have information for people who mow, if you're not able to make it up.**

30) **Sheds and Deck Boxes** – Only one shed, is allowed with a size limit of 6' W x 6' D x 7' H. (No wood, or metal sheds), and two deck boxes 41" W x 21" D x 24" H (Maximum size). Existing wood sheds will be allowed, but cannot be replaced with another wood shed.

31) Only one **face cord** may be stored on your site and must be stacked in a neat pile. The use of skids for firewood is okay; however, they must be broken down. No burning of full skids is permitted. Max dimensions of face cord– H-6' x L-8' x D-18"

32) **Sale of your trailer** – In the event that you sell your trailer, your site will not be included in the sale. Trailers older than the year 2000 will have to leave the park when sold.

33) **Non-Transference** – Your seasonal site will not be passed onto anyone in the event of death or if you leave before the season ends.

34) **Tarping your roof**- If your roof leaks please let us know. You may cover it with a tarp for no more than 10 business days. Tarps are a temporary fix, not a permanent solution. Tarps for winter storage must be removed by May 1st.

35) **No Electric Heaters.**

I/We agree to the conditions and provisions of this Agreement, and agree to comply with them. I/We understand that if we do not comply with the rules and conditions of this agreement, that we may be removed, or will not be offered an agreement for the following camping season. We further agree that we will inform our minor children and guests of the requirements of this Agreement, and be responsible for their behavior and demeanor at the Campground.

I/We understand that our admission to the Campground may be terminated by the Campground, at any time at the sole discretion of the Campground.

Golf Cart Requirements, Inspection, and Waiver of Liability for the 20__ season

1. Golf carts may not be driven in campground without a golf cart license plate.
2. All golf carts must be inspected and approved by staff in order to receive a Golf Cart Plate.
3. Must be a manufactured golf cart, not something modified to be used as a golf cart.
4. Must not be modified, with the exception of adding an aftermarket governor.
5. Must have a muffler, and not be loud.
6. Electric golf carts are allowed, but must pay an additional \$85.00 fee, for seasonal electric charge.
7. Golf carts must be governed at 5mph. If seen going faster than 5 mph, golf cart will be have to be removed from campground. Maintenance staff can govern golf carts for you, if you do not know how. **Golf carts that can not be governed, can not be here.**
8. Golf carts must have a fixed headlight(s) and reflectors in order to be driven after dark.
9. Proof of liability insurance, with a minimum coverage of 100,000.00. (This can easily be added to your homeowners or RV insurance policy)
10. A signed copy of the Golf Cart Requirements and Inspection form.
11. All golf carts must be maintained and kept in good working order. Management reserves the right to refuse registration to carts that are deemed unsafe, or carts that don't fit requirements.
12. All operators of a golf cart must be at least 16 and **possess a valid driver's license**. It is the golf cart owner's responsibility to ensure that anyone without a valid driver's license does not operate the cart.
13. Operating a golf cart while under the influence of drugs or alcohol is strictly prohibited. No drinking and driving.
14. The number of passengers is limited to the number of seats on the golf cart, and passengers must remain seated.
15. Absolutely no children are allowed to drive golf carts or drive a cart while on the lap of an adult. All passengers are to be secure and under control while in your cart.
16. Carts are to be operated in a safe and responsible manner at all times. Stay on common roads at all times and abide by all posted traffic signs.
17. A copy of these rules must be signed by all golf cart owners, and will be kept on file with a copy of the insurance card and registration information.
18. If you would like to store your cart at Lazy Days Campground, Inc. for the winter, there is a \$30 Storage fee.

Liability Waiver: I acknowledge that I have carefully read the "Golf Cart Requirements, Inspection, and Waiver of Liability" form, and fully understand that it is a release of liability.
